By attending the annual meeting on April 22, you can meet the people that are making long-term decisions for Kingfield and Minneapolis, and also vote for the individuals that you think will continue to fight for what is best for the City and our strong neighborhood.

Kingfield 2002 Housing Programs

All KFNA Housing Programs have been redesigned with new, higher program limits to accommodate the rising cost of home repairs. Information and applications for all programs will be available at the KFNA Annual Meeting, Monday April 22, 7-9 pm. Please note: no applications will be mailed for the low-interest 4% Loan or the Matching Grant Program before this date. If you cannot attend the meeting, please call Jim Hasnik, Center for Energy and Environment Program Administrator, 335-5885, and put your name on the mailing list for application materials, which will be mailed the day after the annual meeting.

Emergency Home Repair Grant applications will be available in mid-March. For questions on this program or any KFNA housing program call Sarah Linnes-Robinson at the KFNA office, 823-5980.

All three 2002 housing programs are essentially the same as last year's. Here are the basic facts. Please note: if you received funding from one of these programs in the past, all programs will allow you to reapply and get additional funding this year!

Kingfield's 4% Loan Program is still open to all homeowners, regardless of income, in the neighborhood. The program has, however, doubled the loan amount each house-

hold can receive, up to \$6000. This money can be used for exterior repairs or improvements including roofs, siding, retaining walls, porches, and garages. Previous recipients of the loan are eligible to receive the difference between the balance on their current loan and \$6000. This ongoing program will accept applications beginning April 22 at the KFNA Annual Meeting and will continue to accept applications until all funds have been committed.

KFNA's Matching Grant Program has increased the size of the grant to \$4000. This program is open to homeowners whose income

KFNA Opens New Grant Program for Social Service Projects

In an effort to support the work of those already providing services to Kingfield children, families, youth, seniors, and minorities (whether by race, sex, or sexual preference), grants of up to \$5000 will now be provided to these organizations. Projects serving "basic needs" are considered a priority and will be funded first. Basic needs are defined as food, clothing, safety, health, shelter, and transportation. Projects addressing basic needs may include: health services and information, heat assistance programs, temporary shelters, food shelf supplies, crisis counseling, and/or transportation to local social or public services. Projects that would also be considered may include

subjects such as: bilingual programming for adults and children, after-school classes, and mediation training and/or services.

Grant deadlines are May 6, June 14, August 1, and September 13, 2002. All grants received on and before each deadline will be considered at the same time. Grants will be awarded according to the Preference Criteria as stated in the Program Guidelines until funds have been committed; there is no guarantee of funding beyond the first deadline. Community-Initiated Grants

Did you know that under the Community Initiated Grant Program, KFNA has been making small grants available to groups of neighbors who develop projects which solve an immediate livability concern or which benefit the greater neighborhood? KFNA to Provide Grants for Business Façade Improvements

The Kingfield Neighborhood Association reopens the Business Façade Improvement Program for all commercial addresses that have not received a grant from this program in the past two years. Businesses can receive up to \$12,500, which the business or property owner matches dollar-for-dollar, for exterior visible repairs, replacements, or enhancements to their building. Businesses in Kingfield's targeted Redevelopment Zone (from 35W through the west side of Nicollet Avenue and from the south side of 36th through the south side of 38th Street) may

qualify to have their grant matched by the KFNA Property Redevelopment Program.

Eligible projects may include (but are not limited to) canvas awnings, signage, storefront window replacement, brickwork restoration, and/or exterior lighting. Only businesses that have not received a Business Façade Improvement Grant from KFNA before are eligible for the grant deadlines of May 6, June 14, and August 1, 2002. All commercial zoned properties that have not been approved for a project in 2002 are eligible for the grant deadline of

September 13, 2002. Any grants received on, or before, each deadline will be considered at the same time. Grants will be awarded according to the Eligibility and Preference Criteria as stated in the Program Guidelines until funds have been committed; there is no guarantee of funding beyond the first deadline.

is at, or below, 80% of the metro area median income (see chart at right). The approved grant projects will be based on an inspection and work must be done in the order of severity. Grant projects may include roofs, foundations, rotten wood repair, exterior steps and connected walkways, and/or primary storm windows and doors. Each \$1 from KFNA must be matched with \$1 of the homeowner's money; the match can be from the KFNA 4% Loan, but not the KFNA Emergency Grant Program. Additionally, neighbors who live in Kingfield's targeted Redevelopment Zone (from 35W through the west side of Nicollet Avenue and from the south side of 36th through the south side of 38th Street) may qualify to have their grant matched by the KFNA Property Redevelopment Program. Applications will be available beginning April 22 at the KFNA Annual Meeting and must be postmarked by Monday May 6, 2002. Funds will be granted based upon the severity of the repair problems.

KFNA's Emergency Home Repair Grant Program has also increased the size of the grant to \$4000. An emergency is defined as a condition

that makes a house uninhabitable, extremely dangerous to occupants, or is capable of causing severe health problems. This program is open to homeowners whose income is at, or below, 60% of the metro area median income (see chart above); previous applicants can reapply for an emergency need and could be eligible to receive the difference between their previous grant and the \$4000 program limit. The program will open in

mid-March and funds are available on a first-come first-served basis, until all funds have been committed. Neighbors who live in Kingfield's targeted Redevelopment Zone (from 35W through the west side of Nicollet Avenue and from the south side of 36th through the south side of 38th Street) may qualify to have their grant matched by the KFNA Property Redevelopment Program.

Hennepin County Offers Great Deals on Compost Bins

Due to the overwhelming response of last year's compost bin distribution events, Hennepin County and the Solid Waste Management Coordinating Board are sponsoring another event this spring. Approximately 8,000 compost bins will be distributed throughout Hennepin County on a first-come, first-served basis. The cost of the bins is only \$20, with a retail price of more than \$70!

Backyard composting is an easy way to turn much of the waste from

your yard and kitchen into a rich material that you can use to improve your soil. Using finished compost on your lawn and garden will provide an organic fertilizer, suppress weeds, and hold moisture in the soil. The bin features 13 cubic feet capacity, a sturdy easy-to-open lid, two harvesting doors, and is made with recycled plastic.

Residents must place a pre-order, then pick-up and pay for the bin at one of the following events: Bryn Mawr Elementary School Parking Lot, 252 Upton Ave South, on Satur-

day, April 20th from 9 am - 2 pm; or in Southwest Minneapolis at Anthony Middle School Parking Lot, 5757 Irving Ave South, on Saturday, May 4 from 9 am - 2 pm. Limit one bin per household. The first 2000 residents to place their orders will receive a free kitchen bucket with their bin.



What's the latest with the 40th St. Greenway?

• **A new name:** Our new name, the RiverLake Greenway, was chosen in a community contest for two reasons, both of which reflect our expanded scope. First, the Greenway now is planned to stretch at least from Lake Harriet to the Mississippi. Second, it will follow 42nd St. rather than 40th east of Roosevelt high school. But you can still call us the 40th St. Greenway in Kingfield. That beats "Drunken Sailor Way," one wag's tag for the serpentine design tested last summer!

• **A revised design:** We've listened to your feedback and have gone back to the original proposal. All the bumpouts will be on the north (sunny) side of the road, the curving lanes are gone, and the bike lanes remain. Since speed measurements indicated the serpentine design didn't slow traffic, we're back on the straight and narrow.

• **Construction this summer?** That's still the goal. Jim Daire, our man at Public Works, is trying his best to keep the project on schedule. The variables include passing state design review, fitting into the city's construction schedule or getting an outside contractor, and

getting bids within our budget. We're hoping to take advantage of the current favorable bidding climate.

• **Other neighborhoods:** The East Harriet Farmstead and Standish Ericsson neighborhoods are working with Daire to design their Greenway sections. The Bancroft neighborhood has expressed its desire to go ahead with the project. Longfellow expects to turn its attention to our Greenway after finishing its design for the Midtown Greenway.

• **Bridging the freeway:** If the freeway ramps are moved to 38th St., that means MNDOT will replace the 40th St. pedestrian bridge over the freeway, according to current plans. If that happens, we'd like to see a Kingfield-Bryant neighborhood grassroots design effort for the new bridge.

• **More planning money:** The Laura Musser foundation has awarded the Greenway project \$5,000 to help finance planning in other neighborhoods. We are grateful, and are waiting to hear from the McKnight Foundation on another grant request for similar purposes.

Redevelopment Update

The Kingfield Redevelopment Committee has spent much of the fall and winter focusing on two major issues. The first is the future of the old Good Samaritan Nursing Home, which is currently vacant. As the selling price has come down in recent months, the committee has acted as the neighborhood's first contact for potential buyers. While nothing has been finalized, the plans of most interested parties envision housing on the site.

Secondly, the committee has been examining ways to help the northeast corner of Kingfield (from 35W through the west side of Nicollet Avenue and from the south side of 36th Street through the south side of 38th Street). Changes have been made to the Building Façade Improvement Program and to the Exterior Home Improvement Program to make it easier for businesses and homeowners in this area to take advantage of available NRP dollars. In addition, a design firm has been hired to help provide ideas for the commercial node at 38th and Nicollet. Design drawings will be

completed by mid-April; watch for community meetings to be held between now and then to allow for input and feedback from the neighborhood. Questions? Call Jason Zimmerman, 821.0881.
