

DEVELOPMENT UPDATE FOR 40TH & LYNDALE

In the early 2000's two Super America (SA) convenience stores were located across the street from each other at this intersection, due to the purchase of 7-11 stores by Super America. The residential property directly south of the now vacant Super America was purchased by the company, and the duplex on that property was razed, leaving a vacant lot. It was SA's desire at that time to build a larger convenience store at that location. Abandoning that plan in 2006, Super America instead closed the station, leaving a vacant building.

A joint neighborhood group formed in 2005, made up of Kingfield and East Harriet Representatives, whose mission was to help the 40th & Lyndale business node meet its full potential. This group, called the 40th & Lyndale Task Force, received funding from the city of Minneapolis' Great Streets Program to create a design for the node to meet Great Street standards while balancing the needs and desires of the nearby neighbors and the neighborhoods at large.

The 40th & Lyndale Task Force held a community forum in which more than 60 residents and business owners, including Super America, participated. At this forum, participants expressed a strong interest in amenities that fell under the Walkable Small Retail and Food category. Residents expressed the desire to make the intersection feel like an attractive small town, using 46th and Bryant, 50th & Xerxes and France Avenue as examples. Residents said they wanted community gathering places and stores they could walk to that also would fit into the fabric of a residential neighborhood.

Since 2006, other development has occurred around this vacant site. Lyndale Avenue has been reconfigured from four to two lanes, with expanded greening and pedestrian level lighting. Additionally, the RiverLake Greenway, an east-west pedestrian/bikeway that connects the Chain of Lakes to the Mississippi River has been completed. These changes have helped transform this section of

Lyndale back to a neighborhood avenue in the spirit of a Community Corridor as it is currently classified by the City. According to the 40th & Lyndale Task Force's application to the City in 2006, the vacant commercial building and empty lot are in marked contrast to the return of Lyndale Avenue as a neighborhood corridor and "this intersection as a community gathering point for residents of the two neighborhoods is significant," the task force wrote.

After years of looking at a vacant convenience store and inaction from an unmotivated seller, KFNA learned this spring that a purchase agreement for the site had been signed by a reputable local restaurateur, Paul Dzubnar, owner of the Green Mill franchise. His initial plan for the site met many of the goals identified by the 40th & Lyndale

"As the Councilperson for the 8th Ward, I am excited to see this node finally redeveloped and the vacant SuperAmerica location finally with an active business. I will be disappointed, however, if the final design doesn't fit the desires as stated by residents and the 40th & Lyndale Task Force —

to fit in with the physical characteristics of the neighborhood instead of featuring a parking lot on this highly visible corner — due to the owner's inability to construct a new building on the site.

Task Force and various neighbors, including a build-out to the street, with parking to the side, and a restaurant that would serve as a community gathering place and revitalize the corner.

Nearby neighbors, whose consent is needed to approve the rezoning of the lot for parking, were hesitant about the size of the proposed restaurant, however, and its anticipated impact on the currently quiet corner. Even after concessions by Dzubnar to reduce seating and hours, and following several meetings with neighbors and Council Members Tuthill and Glidden, the new owner has been unable to get the required number of signatures from affected residents to rezone 4008 Lyndale Ave from a R1A to C1 to build a parking lot adjacent to his proposed restaurant, the Crooked Pint.

At the time of the printing of this paper, Mr. Dzubnar is moving forward with an alternate plan, including seeking a charter wine license from the City of Minneapolis that will not require any neighborhood permissions or zoning change. The developer will work with the architect to create a design utilizing the existing Super America building as a restaurant, and most likely the existing signage pole. The projected starting date to begin construction is sometime in July or August of this year. The alternate plan includes:

- Parking in the existing parking lot spaces facing Lyndale Avenue
- Seating for 62 patrons inside
- Outdoor sidewalk café seating 30 patrons along 40th Street
- Closing hours for the restaurant will be those allowed under state and city law for a charter-wine restaurant: 12 AM close on Sunday through Thursday, 1 AM close on Friday and Saturday
- The proposed hours for outdoor seating have not been discussed.


gardeners, who will be able to answer questions. Expect to take home some great tips and ideas from homeowners who work within the confines of city lots in our challenging Minnesota climate.

If you want to block your street, you can do so free through July 23. (Not all streets can be blocked, depending on traffic flow.) From July 24 through August 1, there is a \$100 fee. After August 1, no applications for blocking off a street will be taken.

And we stretched a new muscle last year by advocating for the Vote No position on the two statewide ballot initiatives we voted on last November. All along the way, our community garden, National Night Out block parties, and traveling crime and safety block parties created traditions and structures through which friendships may bloom.

Missed the Kingfield Garage Sale?

Participating in the Kingfield Garage Sale gave me a deadline for going through things that had accumulated over the winter in our closets and bookcases, and my son's toys. The sale also gave me a way to pass these things on. If you missed the sale but still have some excess stuff lying around, here are a few tips for de-cluttering your home.

Whether you are clearing out a junk drawer, basement, or bedroom, consider how you want to use that space. Don't stop at imagining a beautiful room, but really envision what you will do there. Then remove everything. Don't think about it too hard – you can consider each item later. Give the space a quick clean. Since you are not planning on clearing out the space on a regular basis, take the time to get out the cleaning products and vacuum.

Now comes the challenging part — putting things back in the freshly cleaned space. (It's also the fun part, where you get to see progress!)

For each piece, consider the following:

- When is the last time you used it?
- What would you do if you did not have it and needed it?
- Does the item fit your vision for how you will use the space? Things that you don't use or need can go

into boxes marked "donation", "trash", "recycle", and "goes elsewhere." As you get a sense of what belongs in the space and what does not, you can arrange things by how often you use them.

- Put one arm up and one arm down to find your "prime storage space." This might be shelves or cabinets that you can reach without needing to use a stool or bend down. Put the items you use daily there.
- Items that are used once a week can go in places that take a little more effort to access.
- Things that you use once a month or less could be designated to a different room or long-term storage.

Now you have an organized space and a pile of things that you don't need. If the idea of having a garage sale doesn't interest you, a number of Kingfield organizations will happily accept donations. In addition to the Salvation Army at 3740 Nicollet, day cares, churches, and schools usually love donations of kids' items, art materials, and office supplies.

KFNA Crime Prevention and Safety (CPaS) Committee Activities

In May, the CPaS Committee organized a graffiti cleanup. An inspection for graffiti within a two-block radius of MLK Park had already been conducted, and volunteers reviewed the locations that had been identified, and attempted to remove the graffiti from street signs, garbage cans, and electric box wraps. Each location was photographed (including graffiti on concrete surfaces that could not be removed by the volunteers) and submitted to the City via the 311cell-phone application. At the end of the cleanup, volunteers had assisted with the identification and removal of over 25 incidents of graffiti.

In June, the neighbors of the 4300 block of Garfield Ave S hosted this summer's first Traveling Block Party. Amy Lavender, Crime Prevention Specialist from MPD's 5th Precinct, provided information about crime trends in the area, bike safety, and summer community safety. Neighbors demonstrated unicycle and juggling skills and offered entertaining tips for those in attendance. Many thanks to Mr. Bill Miller for offering to have the meeting on his block! If selected, you will work with KFNA to choose a date in July or August and select a theme, and KFNA will assist you in lining up resources and advertising the event to your neighbors.

CREATING A CONTEMPLATIVE SITE FOR FREEDOM FORM NO. 2

Through a grant from the Regional Arts Council, the Chicago Avenue Fire Arts Center (CAFAC) has been commissioned by the park board and MLK Legacy Committee to create a meditative environment for the sculpture *Freedom Form No. 2.* Designed by artist Daniel LaRue Johnson and originally dedicated in 1970, the sculpture was one of the first major public memorials to Rev. Dr. King Jr. after his assassination, and it was recently relocated to its original site in the park.



This summer, the Legacy Committee will engage the community through events in which residents will be asked to consider three different thought-provoking questions. The Fire Arts Center then will create Cor-Ten (weather resistant steel) surrounds for three new granite stone benches. Each surround will have a laser-cut stencil design highlighting one of the questions, as well as the community's answers, stamped into copper sheeting between the surrounds. The intent is the artwork will serve as a call to action.

CAFAC is thrilled to be involved in this project and looks forward to hearing your thoughts and contemplations throughout the summer.

Under Construction along Nicollet Avenue

Since May 1 the reconstruction of Nicollet Avenue has provided a bit of disruption to motorists traveling through the neighborhood. For the businesses within the construction zone, the disruption has been more significant. While each business has faced its own specific challenges, we all have faced the imposing Road Closed signs, detours that pull passersby away, the closing of cross streets that reduce access, and the loss of parking.

The project is nearing the end of its first phase. Then 37th Street will be reopened, and work will progress from 38th to 40th Streets, with hopes of finishing the full stretch by early September.

The phrase "under construction" got me thinking. There have been some great finds under the old roadway, including a stretch of rail and wooden ties, granite pavers, and various assorted pipes. There is always the looming backhoe that you wouldn't want to be under. A new sewer has been put in underground, with many a trench dug and filled under the new road surface. The ground (and floor) has vibrated under our feet many times as the road was torn up and then later as the new layers of gravel and asphalt were tamped down.

We have been under the watchful eye of Bev Warmka from the city, who has done a fantastic job of keeping us up to date, listening to our concerns, fielding our questions, and showing us that she understands that she works for us and is our connection to city services.

"Under" can also refer to underperformance: not being able to meet sales goals and income forecasts due to the disruptions, although even the weather can do some pretty good damage to those numbers. And yes, we've all been under a bit of stress trying to figure out ways to manage cash flow during the construction.

But the biggest "under" would be underestimating the level of support from neighbors and friends who have made efforts to make up for the lower traffic levels at Nicollet Avenue businesses. All of us along the avenue feel very grateful to those who are walking and biking over, setting up meetings, and bringing in friends who might otherwise get nervous about venturing into the construction zone. As we share the challenges of the disruption, we keep each other hopeful for what Nicollet Avenue will become in the years ahead.

The Carrot Initiative Partners with Seward Community Co-op


