By-Law Changes and Updated City Requirement

Highlights of the changes are: The board will now have a minimum and maximum number of board members (5 to 13), Board Members must be 18, Board members must take a 2 year break after 6 consecutive years, Board members will remain board members after the election until the next meeting. These changes are necessary in order to continue to receive money from the city.
