Staff Report

- 3916 Blaisdell (and ADU) City of Lakes Community Land Trust is ready to start the bidding process, CLCLT is looking to be loaned \$150,000 (5% loan rate) \$10,000 will be forgivable if paid off in 18 months instead of 12 months due to COVID.
 - Tabled the motion until we see the loan document (specifically for people who haven't worked with CLCLT processes in the past
- <u>990 report</u>/AG reports and approvals—Board will be review this and supply feedback to SLR on any edits

- Minneapolis Foundation Grant Submitted—If the grant comes to be (written by 5 organizations), KFNA will see the language and will be able to approve or deny.
- <u>Southwest Journal</u>—Conversations have been had with other neighborhood associations to purchase the community newspaper on what was the Southwest Journal.
