## 7:25- MLK Park Summary of 2020 Work with Unhoused Neighbors and Advocacy/Actions Going Forward

Raquel, Sara and Allison came to the board meeting to talk about the support of the unhoused neighbors living in MLK Park and where they are now with their support. 7 volunteers were regularly present in the park. Over the course of the pandemic, 51 individuals were living in the park; 30 were consistent. As of today, 6 residents remain in the park. The volunteers built a philosophy to cause the least harm to the residents of the park. They provided basic needs to get people where they need to be. Their goal was to provide a stable place to stay, basic support and a path forward. The organization People's Laundry came into the park twice a week to do laundry for the unhoused neighbors, In the end, there work was successful because of relationship building, providing an approach forward, and building trust, VP Councilwoman Jenkins came and learned about the barriers and challenges. There was a KFNA sponsored event in MLK Park, which included flu shots, HIV tests, haircuts, bike repairs, housing fair. During the past 2 months, the volunteers continued an individual focus on each resident, where are they going to go, what they are going to do. The park residents were served an eviction notice at end of October, but received an

extension to leave. They will probably receive another eviction notice next week. At that time, one or two people will be displaced.
