KFNA Board meetings are held monthly and are open to the public. Additionally, there is an annual meeting in May of each year. KFNA Prepared and distributed a weekly e-news to almost 3500 individual addresses
June 2023: KFNA hosted Porchfest 2023. Thirty-seven sites hosted bands or individual performances. Attendance was high high compared with previous years, despite air quality issues. August and November 2023: KFNA sponsored Get Out the Vote (GOTV) efforts at Kingfield Park, designed to encourage neighborhood residents to vote in elections held on those days. The Kingfield precincts had among the joghest % of residents voting in the entire city. December 2023: KFNA voted to approve \$100,000 of uncontracted NRP housing dollars to support the 110-unit affordable housing site at 3030 Nicollet. February 2024: KFNA provides significant support for Empty Bowls Kingfield. The estimated attendance was 550. The total revenue was \$14,000, the majority of which was donated to support organizations feeding those in need. March 2024: About 250 neighbors attended the Sap Tap and Pancake Breakfast at MLK park. Ten gallons of syrup were produced, which is a new record. Fron September 2023-May 2024, KFNA provided \$10,000 of financial support from KFNA to RaÃ-ces Sagradas, which implemented a pilot project in

During this time period, KFNA allocated \$10,000 to Kingfield Farmers Market to set up the Power of Produce Program as a pilot location.

Promoted the August primary and November general election with utility-pole posters and yard signs to promote voting at MLK Park. KFNA is proud that these signs will be reused a 6th time to promote this year's local election.
? Held a Polling Parties in August and November and greeted neighbors at MLK Park with food and beverages and friendly faces while thanking them for performing their civic duty and voting (with volunteer crossing guards to help them safely across Nicollet).
